DESCRIPTION

Its formula allows a bactericidal, fungicidal and virucidal action. It has been tested according to EN1276 and EN14476 standards for disinfection. It is a concentrated professional product with a broad spectrum of antimicrobial efficacy suitable for the disinfection of aquatic equipment such as surfaces and premises open to the public. This product is particularly appreciated by nautical clubs.

APPLICATION

ROUTINE DISINFECTION (BACTERICIDE), 1% DILUTION:

- Gradually pour 1 litre of BACTERCLEAN PRO per 100 litres of water into a tray. Mix well.
- Leave equipment to soak for 15 minutes, stirring occasionally to ensure thorough impregnation.
- Leave to dry. Renew the tank regularly.

REINFORCED DISINFECTION (FUNGICIDE AND VIRUCIDE), 5% DILUTION:

- Gradually pour 5 litres of BACTERCLEAN PRO per 100 litres of water into a tray. Mix well.
- Leave the equipment to soak for 15 minutes, stirring occasionally to ensure thorough impregnation.
- Leave to dry. Renew the tank regularly.

SURFACE DISINFECTION (1% OR 5% DILUTION):

- In the case of soiled surfaces, we recommend applying the diluted product after cleaning the surfaces with a conventional detergent. Leave to work until complete evaporation or rinse after 15 minutes.
- For lightly soiled surfaces, you can use diluted BACTERCLEAN PRO directly, without any special preparation or rinsing. Leave to work until completely evaporated or rinse after 15 minutes.

INFORMATIONS

OPERATOR PROTECTION

TRANSPORT AND STORAGE

- •The product must be transported and stored in hermetically sealed containers that are not permeable to solvents.

WASTE
